OLD BUSINESS:

Approval of previous meeting minutes

Previous meeting minutes from July 18, 2019 meeting motioned to be approved by Rick Wiley and seconded by Adley Peltier. Passed 4-0 in favor.

Lafourche Fire District 8-C Board treasurer report

Adley Peltier presented the Board's treasury report. At present the Board's regular account has FIVE HUNDRED DOLLARS AND 00/xx (\$500.00). At present the Board's Parcel Fee Account has TWO HUNDRED THIRTY-FIVE DOLLARS AND 50/xx (\$235.50).

Collections of Delinquent Parcel Payments.

The board talks about the delinquent parcels, of which an up to date list is included in the minutes. After a lengthy discussion the Board has decided to research the parcels that have not paid. After a review of the research, the board will then decide if they will send a certified letter to the address demanding payment. A motion is made by Tony Lafaso to create a Board ordinance, seconded by Rick Wiley. Passed 4-0

Board Discussion of New Election for Parcel Fee Increase

The Board discussed getting onto an election ballot to raise the Parcel fee to \$75.00. The additional funds will increase the total collections by approximately SIXTY THOUSAND DOLLARS and 00/xx (\$60,000.00). The Department is in need of these funds due to the age of equipment and the ever increasing cost of repairs. Rick Wiley makes a motion to contact the previously used bonding attorney to get started with the needed process so that we can get on the April 4, 2020 ballot. Motion seconded by Tony Lafaso. Passes 4-0.

New Business.

The board approved the 2019 Resolution to the Assessor's Office giving the Assessor's Office authority to collect the parcel fee for the Lafourche Parish Fire Protection District 8-C Board. Passes 4-0.

Tony Lafaso makes a motion, seconded by Rick Wiley, to open the floor to the candidates running for the District 2 Lafourche Parish Council Seat. Passes 4-0. The floor is open to Mr. Niles Riche followed by Mr. William Adams.
